## <u>ORDER</u>

He also mentioned that UGC has not issued any instructions to install them and those are personally installed by the university. He also added that university came into existence in year 2012.

4. After hearing both the parties and examining the case file, we observed that Sh. Sukhpal Singh does not aware about the facts of this case. Another opportunity is given to the appellant, Sh. Sukhjeet Pal Singh to present his case before the Full Bench to clear the facts of this case positively, failing to which case will be decide on the available evidences.
