#### ORDER

After hearing the parties concerned, this case was reserved on 27.1.2021 to be pronounced later on.

2. The appellant has sought the information related to the grants received in the Municipal Corporation, District Ludhiana in lieu of Swachh Bharat Mission as follows:-

3. The appellant showed his satisfaction with the information so supplied by the respondent-Public Information Officer pertaining to Point No. 1 RTI application and requested for the information pertaining to Point No. 2,3 and 4 of the RTI application.

4. Regarding Point No. 2 & 3 of the RTI application the respondents have already filed their response vide No. 6671 dated 15.9.2020 which is as follows:-

4. Regarding Point No. 4 of the RTI application, the respondent again filed an undertaking vide No. 6990 dated 12.1.2021 which is reproduced below:-

"ਉਪਰੋਕਤ ਵਿਸ਼ੇ ਤੇ ਹਾਵਲੇ ਅਧੀਨ ਦੱਸਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਪੈਰ ਨੰ: 4 ਸਬੰਧੀ ਸੂਚਨਾਂ ਇਸ ਦਫਤਰ ਵਿੱਚ ਕੰਪਾਇਲ ਕੀਤੀ ਹੋਈ ਨਹੀਂ ਹੈ। ਇਸ ਕਰਕੇ ਇਹ ਸੁਚਨਾਂ ਨਹੀਂ ਦਿੱਤੀ ਜਾ ਸਕਦੀ।

5. It is appropriate to mention the decision given by the Supreme Court of India in the matter of Central Board of Secondary Education & Anr. Vs. Aditya Bandopadhyay & Ors (Civil Appeal No.6454 of 2011) reported as 2011(3)RCT(Civil) and circulated by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel and Training vide No. 1/18/2011-IR dated 16.9.2011 which is as follows:-

"At this juncture, it is necessary to clear some misconceptions about the RTI Act. The RTI Act provides access to all information that is available and existing. This is clear from a combined reading of section 3 and the definitions of 'information' and 'right to information' under clauses (f) and (j) of section 2 of the Act. If a public authority has any information in the form of data or analysed data, or abstracts, or statistics, an applicant may access such information, subject to the exemptions in section 8 of the Act. But where the information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the Act does not cast an obligation upon the public authority, to collect or collate such non available information and then furnish it to an applicant. A public authority is also not required to furnish information which require drawing of inferences and/or making of assumptions. It is also not required to provide 'advice' or 'opinion' to an applicant, nor required to obtain and furnish any 'opinion' or 'advice' to an applicant. The reference to 'opinion' or 'advice' in the definition of 'information' in section 2(f) of the Act, only refers to such material available in the records of the public authority. Many public authorities have, as a public relation exercise, provide advice, guidance and opinion to the citizens. But that is purely voluntary and should not be confused with any obligation under the RTI Act." Contd..P/3
