#### ORDER:

The appellate through RTI application dated 12.03.2020 has sought information on 25 points regarding demolition of walls in District Education Offices Ludhiana – name of branch – date and time of demolition – inspecting officer – names and number of labourers deployed and other information as enumerated in the RTI application concerning the office of DEO(EE) Ludhiana. The appellant was not provided he information after the appellant filed first appeal before the First Appellate Authority on 27.05.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The appellant claims that the PIO has neither provided the information nor has responded to the RTI application.

The respondent is absent. The PIO is directed to provide whatever information is available on record point-wise and send a compliance report to the Commission.

The Commission however, observes that there has been an enormous delay of more than ten months in attending to the RTI application. The Commission has taken a serious view of this and hereby directs the PIO to show cause why penalty be not imposed on him under Section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time. He/she should file an affidavit in this regard. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The PIO is again directed to provide information to the appellant within 15 days of the receipt of this order.

The case is adjourned. To come up for further hearing on **25.05.2021 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Ludhiana.

#### **ORDER:**

The appellate through RTI application dated 14.03.2020 has sought information on 10 points regarding total number of cases in which enquiry against the complaints relating to the period 01.01.2010 to 31.12.2010 and for the period 01.01.2011 to 31.12.2011, 01.01.2012 to 31.12.2012, 01.01.2013 to 31.12.2013, 01.01.2014 to 31.12.2014, 01.01.2015 to 31.12.015, 01.01.2016 to 31.12.2016, 01.01.2017 to 31.12.2017, 01.01.2018 to 31.12.2018 & 01.01.2019 to 31.12.2019 is pending with CVO office Department of Local Govt. Bodies and other information concerning the office of Chief Vigilance Officer, Local Bodies, Pb Chandigarh. The appellant was not provided he information after the appellant filed first appeal before the First Appellate Authority on 21.05.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The advocate appeared on behalf of the appellant informed that PIO has neither provided the information nor has replied to the RTI application even after a period of more than ten months.

The respondent PIO has pleaded that the enquiry on the complaints for which the appellant has sought information is pending. Further all complaints which are received in the vigilance department, are being entered in receipt register and after taking necessary action on the complaints as per instructions, these are entered in dispatch register. Now the entry of the dak received in CVO after 17.05.2017 has been computerized whereas prior to this, the record was maintained manually. Further since the appellant has asked for information from 01.01.2010 to 31.12.2019 relating to pending enquiries, the information is readily not available and has to be created by segregating all dak registers which is very voluminous.

The respondent further pleaded that if the appellant wants information on any specific complaint, he may specify and get the information or he may inspect the record on any working day during office hours.

#### Appeal Case No. 2052 of 2020

Hearing both the parties, the PIO is directed to give in writing on an affidavit that the information is not available in the format as sought by the appellant. If the appellant still wants information, he should inspect the record and get the relevant information by fixing a mutually convenient date and time with the PIO.

The Commission however, observes that there has been an enormous delay of more than ten months in attending to the RTI application. In reply, the respondent informed that he has just joined as PIO and the earlier PIO Sh.Sanjay Tondan is on long leave. The Commission has taken a serious view of this and hereby directs Sh.Sanjay Tondan, earlier PIO to show cause why penalty be not imposed on him under Section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time. He/she should file an affidavit in this regard. If there are other persons of the show cause and direct them to appear before the Commission along with the written replies.

The case is adjourned. To come up for further hearing on **25.05.2021 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Ludhiana.

#### ORDER:

The appellate through RTI application dated 27.03.2020 has sought information regarding number of blocks allotted to Sh.Ajay Kumar Building Inspector in Zone-A date of his joining in the NC – earlier posting of Sh.Ajay Kumar – promotion related file and other information concerning the office of Director Local Govt. Bodies Punjab, Chandigarh. The appellant was not provided the information after the appellant filed first appeal before the First Appellate Authority on 06.06.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The respondent present pleaded that since the information on points 1,2 & 3 relates to MC Ludhiana, the appellant was asked vide letter dated 20.07.2020 to get the information from them. The respondent further informed that since the information on points 4 & 5 being 3<sup>rd</sup> party, it cannot be provided as the 3<sup>rd</sup> party has not given its consent to disclose the information.

However, the PIO has not transferred the RTI application to the MC Ludhiana. The PIO is directed to transfer the RTI application to the MC Ludhiana under section 6(3)of the RTI Act for the information concerning them.

The PIO-MC Ludhiana is impleaded in the case and directed to look at the RTI application being transferred by Local Bodies, Punjab Chandigarh and provide the information on points 1, 2 & 3. The information regarding points 4 & 5 being personal information, I do not see any public interest in revealing this information, hence it may not be provided.

The case is adjourned. To come up for further hearing on **25.05.2021 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Ludhiana
