ORDER

This order may be read with reference to the previous order dated 6.1.2021 vide which the case was adjourned for 19.2.2021 but due to administrative reasons the case was further adjourned for today i.e. 8.3.2021.

2. The appellant has sought the following information:-

 - 3) 63 ਕਾਮਿਆਂ ਵਿੱਚੋਂ ਕਿੰਨੇ ਕਮਰੇ ਕੱਟੇ ਜਾ ਚੁੱਕੇ ਹਨ ਕੱਟੇ ਕਮਰਿਆਂ ਦਾ ਕੱਟਣ ਦਾ ਕਾਰਨ ਦੱਸਿਆ ਜਾਵੇ ।

 - 5) ਪ੍ਰਧਾਨ ਮੰਤਰੀ ਅਵਾਸ ਯੋਜਨਾ 2019-2020 ਮੁਤਾਬਕ ਆਏ 66 ਕਮਰਿਆਂ ਨਾਲ ਕੋਥੇ ਮਕਾਨਾਂ ਨਾਲ ਕੀਤੀਆਂ (Jio Tag) ਲਾਭਪਾਤਰੀ ਨਾਲ ਫੋਟੋਆਂ ਅਟੈਸਟ ਕਰਕੇ ਮੁਹੱਈਆ ਕਰਵਾਈਆਂ ਜਾਣ ।

The appellant states that he has received the complete information but is not satisfied with the reply given by the respondent-Public Information Officer pertaining to Point No. 3 & 4 of the RTI application.
