ORDER

1. The order may be read with our earlier orders dated: 08.09.2021 where the Commission found that the information sought vide RTI application 27.9.2020 is not completely 3rd party and it was ordered to supply the information except aadhar card etc. which is exempted. The case was adjourned to 08.03.2022 i.e. today.
2. In today's hearing, complainant states that requisite information is still pending from the respondent PIO(s) even after Orders of the Commission dated 08.09.2021. He pleads for intervention to supply the information.
3. The respondent, Sh. Anshuman states that the information cannot be supplied that the information relates to 3rd party and further state that as per Hon'ble Supreme Court directions that cannot be supplied.
4. After hearing both sides, the Commission is of the view that the information sought for is not completely 3rd party and can be delivered. Accordingly, version of the respondent is overruled and he is directed to comply with the previous Orders of the Commission dated 08.09.2021 within ten days from today, under intimation to the Commission, as documentation fee amounting Rs. 3,092/- has already been deposited by the appellant.

Both the parties are advised to represent this case on the next date of hearing positively, failing to which case will be decided on merit basis.
