The appellant through RTI application dated 31.07.2018 has sought information regarding backlog of scheduled caste category posts of lineman under approved direct recruitment in the state of Punjab and other information concerning the office of Deputy Chief Engineer, Personnel, PSPCL Patiala. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 17.09.2018 which disposed off the appeal on 26.10.2018 with the directions to the PIO to provide the remaining information to the appellant as per available record within two weeks.

The respondent present pleaded that the information has been provided to the appellant. The appellant informed that he has received a letter dated 12.02.2019 from the PIO whereby the PIO has denied the information. The respondent informed that there is no backlog of the posts of lineman since they have already stopped direct recruitment on such posts and the vacancy if any against the post of lineman is filled through promotion.

After hearing both the parties, the Commission directs the PIO that if the post of lineman still exists, to provide the information and if the post does not exist, then give it in writing. Further if the recruitment of this post has been stopped, to provide the decision. The information be provided within a week.

With the above directions, the case is **disposed off and closed.**

**ORDER:**

The appellant through RTI application dated 15.09.2018 has sought information on 8 points regarding number of stray cows and buffalos roaming upon the roads and other areas in the jurisdiction of MC Ludhiana and steps to lift the stray cows and other information concerning the office of MC Zone-A Ludhiana. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 22.10.2018 which took no decision on the appeal.

The respondent present pleaded that the information regarding points 1, 2 & 3 has been provided to the appellant vide letter dated 19.11.2018 and since the information regarding points 4,5&6 relates to the PIO-Account Branch, MC Ludhiana, they have transferred the RTI application to their account branch on 26.11.2018.

I have gone through the reply and observed that the RTI application for information on points 4,5 & 6 has been transferred on 26.11.2018 but with an enormous delay since it was to be transferred within 5 days. The PIO has also not adequately responded points 7 & 8.

The appellant is absent and no particular discrepancy has been pointed out by the appellant. It appears that the information on points 1,2& 3 has been provided to the best possible extent. However, since there is delay in transferring the RTI application regarding points 4, 5 &6, the PIO is directed to explain the reasons for delay in transferring the RTI application.

Further since the information regarding points 4,5&6 is in the custody of the accounts department, The PIO-Accounts Department, MC Ludhiana is impleaded in the case with the directions to provide the information on points 4 5 &6 as per the RTI application and explain the reasons for not attending to the RTI application within the time prescribed under the RTI Act.

The case is adjourned.. To come up for further hearing on **29.05.2019 at 11.00 AM.**
