Present:- Shri Narinder Pal Singh, appellant, in person.

Shri Davinder Singh, Deputy Superintendent of Police, Mohali alongwith

Shri Daljit Singh, Assistant Sub Inspector on behalf of the respondents.

ORDER

In this case, during hearing on 06.11.2018, the appellant informed that compensation amount of Rs. 1000/- had not been paid to him nor the requisite information had been provided to him. None was present on behalf of the respondent-PIO without intimation. Viewing the defying attitude of the PIO seriously, compensation amount of Rs. 1000/- awarded on the last date of hearing was enhanced to Rs. 3,000/- to be paid to the appellant through Bank Draft before the next date of hearing. Besides, a Show-Cause Notice was issued to Shri Davinder Singh, S.H.O., Police Station, Shimlapuri, Ludhiana for imposition of penalty. He was also asked to avail an opportunity of personal hearing on the next date of hearing before imposition of penalty. The case was adjourned to 05.12.2018.

- 2. On 05.12.2018, the appellant informed that compensation had not been paid to him nor the requisite information had been supplied to him. None was present on behalf of the respondent PIO. Viewing the callous and lackadaisical attitude of Shri Davinder Singh, SHO, Police Station, Shimlapuri, Ludhiana, one last opportunity was afforded to him to submit reply to the Show-Cause Notice issued to him by the Commission, supply the requisite information to the appellant and pay compensation amount of Rs. 3000/- to the appellant through Bank Draft, before the next date of hearing, failing which action for imposing penalty would be initiated exparte. He was again offered an opportunity of personal hearing on the next date of hearing before imposition of penalty. The case was adjourned to 05.02.2019. After the hearing was over and the appellant had left, Shri Rajiv Kumar, M.H.C., Police Station, Shimlapuri, Ludhiana, appeared before the Commission and he was apprised of the proceedings taken place during the hearing of the case.
- 3. On 05.02.2019, the appellant informed that no information had been supplied to him nor compensation amount of Rs. 3000/- had been paid to him. Reply to the Show Cause Notice issued to Shri Davinder Singh, S.H.O. Police Station, Shimlapuri, Ludhiana had also not been filed by him till date. Even then, while taking a lenient view, one last opportunity was afforded to him to file reply to the Show-Cause Notice issued by the Commission and supply requisite information to the appellant before the next date of hearing. Besides, compensation amount of Rs. 3,000/- was enhanced to Rs. 5000/- to be paid to the appellant, by the Public Authority through a Bank Draft, for the loss and detriment suffered by him, before the next date of hearing. The case was adjourned for 13.03.2019.

- 4. On 13.03.2019, the appellant informed that neither information has been supplied to him nor compensation amount has been paid to him. None was present on behalf of the respondents without any intimation. It had come to the notice of the Commission that Shri Davinder Singh, SHO, Police Station, Shimlapuri, Ludhiana had been promoted as Deputy Superintendent of Police and posted at Mohali and Shri Parmod Kumar has been posted as Station House Officer, Shimlapuri, Ludhiana. Accordingly, Shri Davinder Singh, DSP was directed to submit reply to the Show-Cause Notice issued to him by the Commission for the delay in supply of information and avail an opportunity of personal hearing on the next date of hearing, failing which action will be taken for imposing penalty upon him ex-parte and Shri Parmod Kumar, present SHO, Police Station, Shimlapuri, Ludhiana was directed to supply the requisite information to the appellant and pay compensation amount of Rs. 5,000/- to the appellant before the next date of hearing and submit compliance report on the next date of hearing.

has been initiated by the department. The appellant is advised to send a copy of the complaint

to the respondents, who will take action on its receipt. The respondents are directed to send a

demand draft of Rs.5000/- within ten days. The respondents assure that action will be initiated

on receipt of photocopy of application and they will give compensation amounting to Rs.5000/-

through bank draft within ten days. The respondents assure that they will send the

compensation amount of Rs.5000/- through demand draft positively by ten days. On the

assurance of the respondent, the present case is disposed of and closed. Copies of the order

be sent to the parties.

file, it is revealed that Shri Ram Singh, ASI, has relinguished the charge without handing over

the charge. Disciplinary action against Shri Ram Singh, ASI, has been initiated by the

department. The appellant is advised to send a copy of the complaint to the respondents, who

will take action. The respondents are directed to send a demand draft of Rs.5000/- within ten

days. The respondents assure that action will be initiated on receipt of photocopy of application

respondents assure that they will send the compensation amount of Rs.5000/- through demand



#### ORDER

On 4.10.2018, the representative of the respondents stated that information regarding copies of Government letter dated 1.7.2017 and 23.2.2017 and Punjab Public Service Commission's letter dated 21.10.2016 for reconsideration of the case and Commission's advice dated 27.2.2018 had been supplied to the appellant. The appellant stated that partial information had been received from the respondents vide their letter dated 23.07.2018 and no information regarding file notings and correspondence between the Government and Punjab Public Service Commission had been provided to him till date. Accordingly, it was directed that original file pertaining to this case be brought on the next date of hearing for the perusal of the Commission to enable it to arrive at a logical conclusion and the case was adjourned to 6.12.2018.

- 3. On 612.2018, it was revealed that complete information except proceedings of the meeting of Punjab Public Service Commission, Patiala, where the decision regarding imposition of punishment, had been provided. The respondents were directed to give a copy of extract of proceedings without signatures of the members to the appellant. With this direction to the respondents, the case was disposed of and closed.
- 4. The appellant-Dr. Gupta vide his email dated 07.02.2019 brought to the notice of Hon'ble CIC that no information had been provided to him so-far. He had requested that this case may be reheard at the earliest and PIO be directed to provide information immediately. The appellant had also requested to invoke provisions of Section 19 and 20 of RTI Act, because it had been sufficiently proved that the authorities in the Punjab Public Service Commission were deliberately and intentionally delayed the sought for information. In view of the request of the appellant, the case was fixed for rehearing on 13.03.2019.
- 5. On 13.03.2019, the appellant expressed his dissatisfaction with the provided information stating that file notings, as per his request under RTI Act, 2005, had not been provided to him. While quoting a judgment of Central Information Commission, New Delhi in G.S. Sandhu vs. Union Public Service Commission, the appellant requested that the PIO of the Punjab Public Service Commission, Patiala, may be directed to provide him a duly attested copy of file noting relating to his case. Consequently, after hearing both the parties and going through the said judgment of

Central Information Commission, the PIO of the Punjab Public Service Commission, Patiala was directed to supply a duly attested copy of file notings to the appellant and the case was adjourned to 08.04.2019.

6. On 08.04.2019, the respondent places on record letter dated 3.4.2019 enclosing noting portions of file regarding taking disciplinary action against the appellant, a copy of which has been sent to the appellant, which might have been received by him. The appellant states that copies of noting portion and correspondence between the Punjab Public Service Commission and the Government have not been provided to him. The representative of the respondents has brought original file for the perusal of the Commission and further states that complete information has been provided to him and nothing has been kept pending, which could be supplied to him. The appellant states that copy of one letter supplied to him is not legible. representative of the respondents is directed to provide a copy of the said letter during the hearing. On this, he states that he will send the same to the appellant through registered post. The appellant states that he has doubt that they shall not furnish the same. So the appellant was allowed to take picture of the said letter. The appellant has taken picture of the said letter during the hearing. The representative of the respondents states that complete information as per his application for seeking information under the RTI Act, 2005 has been provided and nothing has been kept pending, which could be supplied to the appellant.
