4. The respondent states that the proper reply to the RTI of the appellant has already been sent to the appellant.

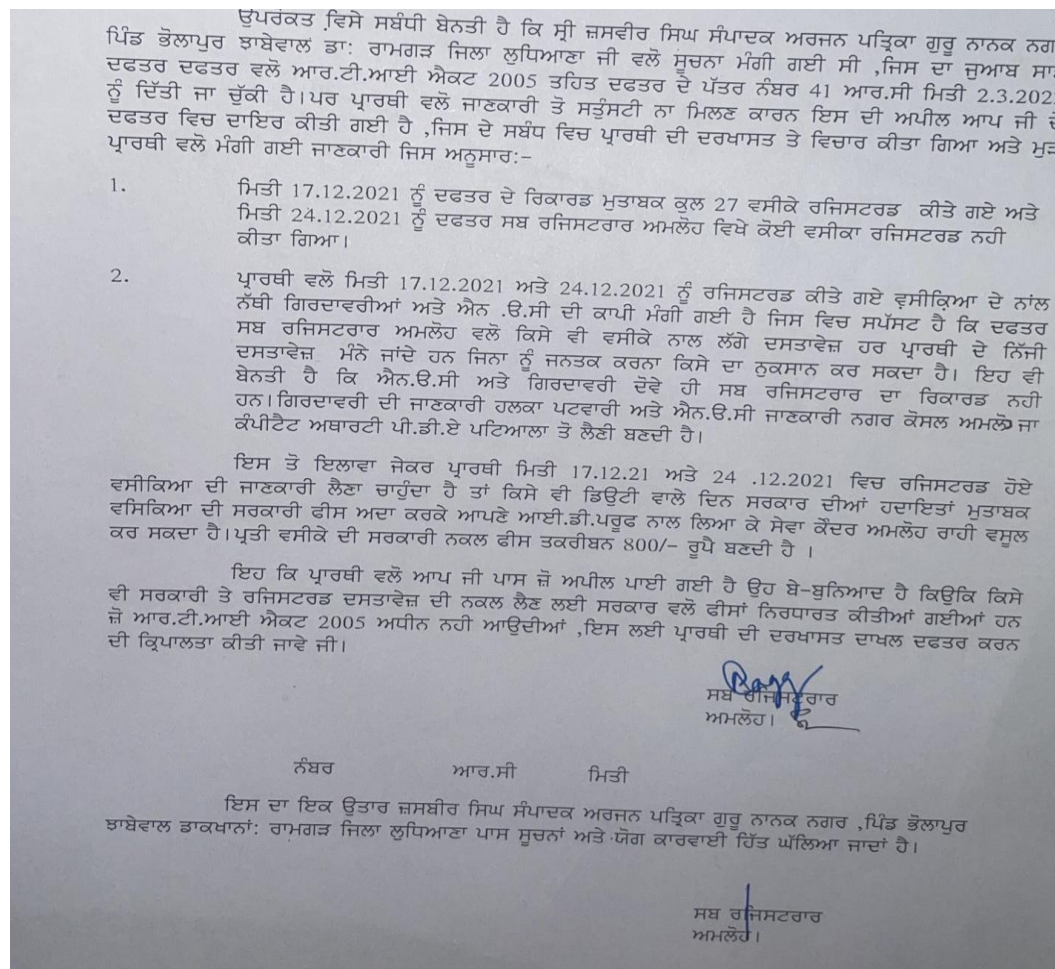
5. After hearing the respondent and going through the case file, it is observed that the appellant Sh. Jasbir Singh has demanded following information:-
