After hearing both the parties and examining the documents placed on record, I am of the considered view that sufficient information has already been supplied to the appellant which fulfills all the aspects of the RTI application. ORDER

1. This order may be read with reference to the previous order dated 12.05.2021 vide which respondent, Sh. Satveer Singh states that demanded information has already been supplied twice to the complainant dated 09.12.2020 and 07.04.2021.

Complainant, Sh. Sunny Marwaha was absent despite being aware of the date of hearing. A call was made to him by the undersigned bench in this regard too but he had not joined the meeting today to represent his case.

One opportunity was given to the complainant to represent this case in person on the next date of hearing positively along with advice to point out the deficiency, if any, in writing to the respondent PIO with a copy to the Commission within ten days of receipt of this order, failing to which case will be decided in his absence. Matter was adjourned for further hearing on 08.07.2021 i.e. today.

2. In today's hearing, respondent, Sh. Satveer Singh states that an email dated 07.07.2021 is sent to the undersigned Bench comprising an acknowledgment of receiving the information, signed by the appellant dated 11.05.2021 (which is received and taken on record).
3. Appellant is consecutively absent second time without any intimation to the Commission. It is observed that he had not pointed out any deficiency in the supplied information. It is presumed that he is satisfied with the supplied information (as per email of the respondent dated 07.07.2021) and does not want to pursue this case further as the appellant has not availed the opportunities given to him to represent this case.
4. In view of above, no further cause of action is required in this case. Hence, this instant appeal case is **disposed of & closed**. Announced in the Court. Copy of the order be sent to the parties.
