3. The Respondent states that the information sought by the Complainant relates to a third-party . Moreover, the so-called third-party has also given her consent not to provide her personal information to anyone. Hence, the information has not been provided to the Complainant.
4. The perusal of the file shows that the information sought by the complainant relates to a third-party and the so-called third party has also denied to provide her information to anyone.
5. In my view, the information for which the complainant has applied falls squarely within the ambit of Section 8(1)(d) as well as Section 11 of the Act and the denial thereof by the respondent is therefore upheld. In view of the foregoing, no cause of action is left, the appeal filed by the appellant is therefore **disposed of and closed**. Copy of the order be sent to the parties.
