ORDER

The RTI application is dated 10.01.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 08.09.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 14.07.2020. On 14.07.2020 the above said appeal was postponed and fixed for hearing on 08.09.2020 i.e. today.

3. The Appellant Sh. Nitin Kumar Garg states that no information has been provided to him so far.

4. The Respondent states that the information sought by the Appellant cannot be provided to him as the information sought is pending under an enquiry. The Respondent has also filed their reply vide Commission diary no. 8095 dated 13.08.2020, which is as under:-

"The record sought by the appellant was not be provided to him as per law under section 8(H) of RTI Act 2005. As, appellant was asking record of inquiry conducted in above said matter, which is factually was a matter of source Information Report (S.I.R) not a matter of inquiry.(2) In other words, Deputy Superintendent of Police, Vigilance Bureau, Unit Hoshiarpur has generated a source information Report (which is a secret Report) about working of Improvement Trust, Kartarpur, District Jalandhar, which

cannot be disclosed as per law. (3) This Source Information Report was sent to Deputy Inspector General of Police, Vigilance Bureau, Punjab, SAS Nagar for further necessary Action and ultimately after consideration, this S.I.R was sent to Addition Chief Secretary, Government of Punjab, Local Body Government Punjab by Vigilance Bureau Punjab, SAS Nagar for further action into the matter. As such in view of above said facts, the said record was not provided to Appellant by explaining the reason U/S 8(H) of RTI Act 2005".

The copy of the same is taken on record.

5. The Appellant has to peruse the same and will file his response/rejoinder.
