I have gone through the RTI application dated 25.11.2020 and also gone through letter no.267648/49 dated 06.01.2021 vide which the information was sent to the appellant by the SPIO and heard both the parties i.e. the appellant, her counsel and the SPIO at length involving in this appeal case.

Before discussing the case, I would like to go through the definition of information as defined U/s 2(f) of the Right To Information Act, 2005, which defines the "information" as following:-

"information" means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;

Appeal Case No. 1920 of 2021

After hearing both the parties and going through the case file, specifically the RTI application dated 25.11.2020, the information sent by the SPIO, duly attested affidavit dated 07.09.2021 submitted by the SPIO and the representation given by the appellant, I feel that some points in the RTI application does not come within the definition of 'information' as envisaged U/s 2(f) of the Right To Information Act, 2005.

The Public Information Officer is duty bound to provide the information to the information seekers in the form in which the information lies in the office of the public authority and he is not supposed to generate, create, collect and collate the information.

Shri Paramjit Singh, SPIO-Superintendent, O/o District Education Officer (SE), Ludhiana has provided the information to the appellant vide letter no.267648/49 dated 06.01.2021 and then 13 pages of information was provided to the appellant on 31.08.2021. The SPIO also stated that the information which was available in the office of the public authority i.e. District Education Officer (SE), Ludhiana has been provided to the appellant and except that no other information is available in the office of the public authority. Then in compliance to the Order dated 01.09.2021 Shri Paramjit Singh, SPIO-Superintendent has submitted two sets of affidavit dated 07.09.2021 duly attested by Notary Public and one original affidavit has been handed over to the appellant during the course of hearing.

I have gone through the contents of the affidavit dated 07.09.2021 and it is submitted by the SPIO that the information which was available in the office of the public authority i.e. District Education Officer (SE), Ludhiana has been provided to the appellant as per annexure and except that no other information is available in the office of the public authority.

I have heard both the parties and gone through the case file, specifically the duly attested affidavit dated 07.09.2021 submitted by Shri Paramjit Singh, SPIO-Superintendent, O/o District Education Officer (SE), Ludhiana that the information which was available in the office of the public authority i.e. District Education Officer (SE), Ludhiana has been provided to the appellant and except that no other information is available in the office of the public authority i.e. District Education Officer (SE), Ludhiana.

So, as the information sought by the appellant, which was available in the office of the public authority i.e. District Education Officer (SE), Ludhiana has already been provided to the appellant and except that no other information is available in the office of the public authority i.e. District Education Officer (SE), Ludhiana, so there is no need to proceed the case further. Hence the present appeal case is **disposed of and closed.**
