The appellant is present today, but none has appeared on behalf of the SPIO, O/o Deputy Commissioner, Ludhiana, whereas ASI Ramesh Kumar is present on behalf of the SPIO, O/o Commissioner of Police, Ludhiana.

I have gone through the RTI application dated 12.03.2019 and also discussed about the sought for information with both the parties.

The complainant/applicant stated that the sought for information has not been provided to her by the SPIO till today.

So, the concerned SPIOs are directed that they should file reply to the complaint filed by the complainant/applicant and send the same to the Commission as well as to the complainant/applicant within 10 days. IN case of non compliance of the Order of the Commission strict action will be taken against the concerned SPIOs under the provisions of the RTI Act, 2005..
