Nevertheless, an opportunity is given to the respondent PIO concerned to bring a copy of the information (which was already supplied to the appellant) with the relevant official record in the Commission before the bench of the undersigned on the next date of hearing fixed in the office of State Information Commission, Punjab so that facts of this case could be cleared.

If the respondent PIO would not appear before the Commission to attend the hearing, action would be taken against him as per provisions of the RTI Act.
