### ORDER:

This order may be read with reference to the previous order dated 14-01-2021.

2. The appellant that information of Point No.2, from the the PIO O/o the District Revenue Office, Barnala has not supplied till date.

Therefore, viewing the defying attitude of the Respondent-PIO, O/o DRO Barnala, a **Show Cause Notice** under Section 20(1) of the RTI Act, 2005, is issued to Shri Harbans Singh, Tehsildar, Barnala to explain reasons through a duly attested affidavit as to why a penalty at the rate of Rs. 250/- per day, subject to a maximum of Rs. 25,000/- be not imposed upon him for the delay in the supply of information and also as to why a suitable compensation under Section 19 (8)(b) of the RTI Act, 2005, be not awarded to the complainant for the loss and detriment suffered by him. He is also afforded an opportunity of personal hearing on the next date of hearing, before taking any action.
