On this, EO, Sh. Manohar Singh states that the due to electricity issue they were unable to print out the information for the Appellant and it is voluminous in nature. He further assures that the information is ready with them today and the Department has no issue if the Appellant could collect the same by today.

In view of above, the Appellant is directed to visit the concerned office today i.e. 09.02.2021 positively for collecting the requisite information from the EO, Sh. Manohar Singh and if the Appellant doesnot visit the concerned office for collecting the record then it will be presumed that he does not require the information any more and the case will be decided on merits.

If the requisite information as per RTI Application is not ready with Sh. Manohar Singh, EO or it would not be supplied to the Appellant by today than it would be presumed that he is misleading the Court and further strict action would be recommended against him, on the next date of hearing.
