1. The RTI application is dated 10.08.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.09.2020 and the second appeal was filed in the Commission on 11.11.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing has been issued to the parties by the Commission for 09.02.2021 through V.C. in D.C. Office, Ludhiana. The appellant has not come to attend the hearing through V.C. He has, however, sent an e.mail dated 08.02.2021 stating that he has to attend Antim Ardas of his relative at Jalandhar and as such, he will not be able to attend the hearing.

3. Shri Asis Singh, Project Coordinator O/o S.T.C. Punjab, Chandigarh comes present to attend the hearing in person before the Bench. He states that the information has been supplied to the appellant vide letter dated 20.11.2020. He further states that information on Point No.1 has been supplied, whereas the information on Points No.2 & 3, being third party information, cannot be supplied and as regards Point No.4, no information is available in the official records.
