On not receiving information from the PIO or on filing First Appeal with the First Appellate Authority (hereinafter FAA) on 21.05.2021, the Appellant filed Second Appeal in the Commission on 27.07.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 31.01.2022.

### ORDER (FIRST HEARING):
