3. Respondent states that the complete information has already been provided to the appellant. He has also given in writing stating that " *the copies of ECR and contingents that are available with us is MCL has been provided to Mr. PC Garg as on 04.04.2019. And no further information is available with us.*"

4. After hearing both the parties and the perusal of the record reveals that the department had not implemented the Section 4 of the RTI Act 2005. According to Section 4, it is mandatory for every public authority shall maintain all its records duly catalogued and indexed in a manner and the form which facilitates the Right to Information under this Act and ensure that all records that are appropriate to be computerized, within a reasonable time and subject to availability of resources, computerized on connect through a network all over the Country on different systems,

so that access of such records is facilitated. Respondent PIO is warned to be more careful in future while dealing with the matters pertaining to the RTI Act, 2005 and act swiftly.
