The PIO, Sh. Arun Kumar is directed to appear in person on the next date of hearing positively else an action could be recommended against him to his higher authorities.

Final opportunity is given to the PIO and he is directed to submit a copy of challan receipt to the Commission after depositing the penalty by the next date of hearing positively and the PIO concerned is also directed to supply complete information to the Appellant with a copy to the Commission by the next date of hearing.
