## **ORDER**

1. This order may be read with reference to the previous order dated 09.03.2020 and fixed for hearing on 24.03.2020 but due to Lockdown the present case is fixed for hearing today.
2. Appellant, Ms. Rupinder Kaur states that partial information, which is provided by the respondent PIO is irrelevant and Rs. 4,600/- has been demanded by the respondent after the stipulated time period.

- 4) ਲੜੀ ਨੰਬਰ 5 ਅਤੇ 6 ਨਾਲ ਸਬੰਧਤ ਜਾਣਕਾਰੀ ਦੀਆਂ 2300 ਕਾਪੀਆਂ ਬਣਦੀਆਂ ਹਨ। ਇਹਨਾਂ ਕਾਪੀਆਂ ਦੇ 2 ਰੁਪਏ ਪ੍ਰਤੀ ਕਾਪੀ ਦੇ ਹਿਸਾਬ ਨਾਲ 4600 ਰੁਪਏ ਅਤੇ 500 ਰੁਪਏ ਡਾਕ ਖਰਚਾ ਨਗਰ ਨਿਗਮ, ਅੰਮ੍ਰਿਤਸਰ ਦੇ ਖਾਤੇ ਵਿੱਚ ਜਮ੍ਹਾਂ ਕਰਵਾ ਕੇ ਰਸੀਦ ਵਿਭਾਗ ਨੂੰ ਮੁਹੱਇਆ ਕਰਵਾਈ ਜਾਵੇ। ਤਾਂ ਜੋ ਆਪ ਨੂੰ ਜਾਣਕਾਰੀ ਮੁਹੱਇਆ ਕਰਵਾਈ ਜਾ ਸਕੇ।

Vishal Wadhawan is directed to make sure appellant has inspected the record as per RTI application along with directions to represent this case on the next date of hearing positively to clear the facts of this case, failing to which case will be decided on merit basis. A copy of this order be sent to him through registered post for his ready reference.
