On the last date of hearing, held on 16.03.2021, the respondent PIO was directed to send the requisite information to the appellant through registered post and the appellant was advised to point out deficiencies in the information supplied to him.

Sh. Avtar Singh, Senior Assistant, who appeared on behalf of the respondent PIO in today's hearing, states that in response to the RTI request, the requisite information has already been supplied to the appellant vide letter no. 761 dated 09.07.2020 and again vide letter no. 18798 dated 17.02.2021 through registered post.
