

3. The appellant states that he has not received the complete information in this case. However, the respondent-Public Information Officer has sent the written submission in this regard, which is taken on record. She also states that the Para no.8 has been mentioned in the letter inadvertently and the same may be read as Section 3, Sub-Section 2 of the Punjab Village Common Lands (Regulation) Rules, 1964. She also states that nothing is available on record as has been sought by the appellant and requested to close the case.

The reply filed by the respondent-Public Information Officer is reproduced below:-

It is appropriate to mention that the "Information" means as per the provisions of the RTI Act, 2005, any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, report, papers, samples, models data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.
- 5. Furthermore, it is relevant to mention Section 2 (*j*) of the RTI Act, 2005 which is as follows:-

"right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to—

- (i) inspection of work, documents, records;
- (ii) taking notes, extracts or certified copies of documents or records;
- (iii) taking certified samples of material;
- (iv) obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.
