She also mentioned that appellant was called twice by the First Appellate Authority but appellant was not appeared and case was disposed of & closed by the FAA. She added that an email in this regard is also sent to the undersigned bench. Email dated 08.06.2021 is received by the undersigned bench, which is taken on record.
3. Appellant is consecutively absent second time without any intimation to the Commission. Notice of hearing dated 02.03.2021 and copy of previous order dated 02.03.2021 were sent to the appellant through registered post but till date no response from the appellant.
4. After hearing the respondent and examining the case file, it is observed that appellant sought information vide RTI application dated 21.03.2020 relates with attested copy of driving license of Sh.
