When no information was provided to him by the SPIO then he filed First Appeal before the First Appellate Authority on 08.09.2020 and then Second Appeal before the Punjab State Information Commission on 11.11.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties to be heard **through CISCO Webex Meetings Software.** 

Both the parties are present today.

The respondent stated that the information has already been sent to the appellant through registered post on 10.02.2021.

On the other hand the appellant stated that the information sent by the SPIO is incomplete.

So the appellant is directed that he should submit the deficiencies in writing to the notice of the SPIO within 5 days and the SPIO is further directed that in case the appellant would submit the deficiencies, then he should send the attested copies of information regarding the deficiencies to the appellant within a week from the receipt of deficiencies and compliance be sent to the Commission accordingly.
