3. Respondent, Ms. Jasbinder Kaur states a similar case (AC: 829 of 2022) was heard by the undersigned Bench on 04.08.2022 and requests the Commission to close this instant appeal case.
4. After discussing with both the parties in detail and examining the material placed on record, respondent PIO is directed to supply the point-wise reply/information to the appellant after collecting from the concerned office, within ten days after receipt of this order, failing which stern action will be initiated against him.
5. Matter is adjourned for further hearing on **22.09.2022 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application), as another appeal case 829 of 2022 is also fixed for the same date. Copy of the order be sent to the parties.

ORDER

1. The RTI application is dated 1.10.2021 vide which the appellant has sought information as enumerated in his RTI application.
