- 2. In this appeal i.e. AC: 2733 of 2021, the Appellant- Sh.Ramandeep Singh Ahluwalia filed RTI application on 27.03.2021 with the PIO, O/o EO,MC, Mandi Gobindgarh *seeking* various information.
- 3. During the hearing of the case held on 01.07.2022 the respondent PIO produced copy of the stay order dated 16.06.2022 granted by Hon'ble Punjab and Haryana High Court in CWP No. 13567 of 2022. The Respondent-PIO states that the information demanded in this case is similar in nature hence, the information cannot be provided. Further, the Respondent has requested the Bench to pass appropriate orders in view of the aforesaid position.
- 4. The Appellant states that the information cannot be denied to him as the Respondent has demanded documentation fee of Rs 228/- from him and he has deposited the same. He has also filed his submissions through e-mail which is taken on record.
