The respondent represented by Ms. Avtar Kaur, Clerk, states that that the appellant has been informed about the same. The appellant denies having received any information. The respondents are directed to furnish to the Commission a copy of the information reported to have been sent to the appellant. If the same has not reached him, they are again advised to send it to the appellant complete in all respects.

24.07.2019:-

Mrs. Shimla Rani, Accounts Clerk who appears on behalf of the BDPO Guruhar Sahai, submits that an amount of Rs.70,000/- was sanctioned under Indira Awas Yojna which was desirable to be disbursed to the beneficiary in three installments. However, Rs.42,000/- out of sanctioned amount could not be remitted due to technical reason. It is a serious step. The Commission directs the BDPO Guruhar Sahai to look it and provide complete information to the information seeker under intimation to the Commission. The Commission further finds that the original application was filed on 15.12.2018. The respondents have failed to provide the information within a stipulated period.

BDPO/PIO, Guruharsahai is hereby issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay / denial of the information to the RTI applicant and why the compensation be not awarded to the Appellant under Section 19 (8) (b) of the Act for the detriment suffered by him.

In addition to the written reply, the PIO is also given an opportunity under Section 20 (1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

The case has come up today. Sh. Sarabjeet Singh, BDPO, is present in person. He states that the amount of Rs. 42,000/- as mentioned in the aforesaid orders though was attempted to be transferred to his account through RTGS, but due to some technical reasons the same could not be credited to his account. Indra Awas Yojna according to him has been discontinued by the Government of India and has been replaced by Prime Minister Awas Yojna. The Commission finds that no malafide on the part of the respondents is involved. However, due to some lapse probably on the part of some officials in the office of the BDPO, the amount which was sanctioned in the favor of the appellant was surrendered to the Government having been unutilized.

The appellant obviously has been put to serious detriment for no fault. The Commission would like to desire the Director, Department of Panchayat and Rural Development as well as the incumbent BDPO to ensure that his case is retaken up under the Prime Minister Awas Yojana and he is recompensed with the undisbursed amount for the funds received under the same. The matter is **disposed** accordingly.


