4. The Bench observes that Shri Bharat Bhushan Mattu, appellant has absented himself during the previous three consecutive hearings and on each hearing, he has been contacted on mobile phone. The appellant never tries to either attend the hearing or even to contact the Bench with regard to his appeal case. This indifferent attitude on the part of appellant is not appreciated. This time, he is contacted on mobile phone. He admits the receipt of information but he denies the receipt of the data sheet regarding the repair work of the vehicle got done. He is apprised of the version of the PIO that the data sheet is not available in their official records.

5. Post deliberations and after hearing the version of the PIO O/o R.T.A. Jalandhar Shri Manish Pagma, he is directed to file an affidavit on non-judicial stamp paper within fifteen days duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.2348 of 2020 has been supplied and nothing beyond that is available in the official records. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
