Moreover, at the time of hearing, it emerges that the appellant filed eight other RTI Applications, which are fixed for today, to the same Public Authorities and subject matter of the demanded information is similar in nature with slightly changes and disclosure of such information occupies huge time period in collecting and furnishing information to supply the same to the appellant.

After discussion it is found that the appellant Sh. Naresh Gupta has also been blacklisted in order passed by the Hon'ble Maninder Singh Patti dated 20.07.2022 in AC No. 3453, 3454, 3455, 3456, 3457, 3458, 3459, 3460, 3461, 3462, 3463, 3464, 2057 of 2021 on 20.07.2022 from the date of passing of the judgment dated 20.09.2022.

6. However, taking into consideration the language used by the appellant, it would be appropriate that the matter is referred to another bench for due consideration and taking an appropriate final decision in the matter.

7. In view of the foregoing, the case file is sent to Deputy Registrar for placing the same before the Hon'ble Chief Information Commissioner for appropriate orders. Copies of the orders be sent to the parties.
