1. The RTI application is dated 29.12.2018 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 01.05.2019 and second appeal was filed in the Commission on 22.10.2019 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 09.12.2019 by the Commission.

3. The appellant states that he has received only one letter dated 04.02.2019 from the PIO stating that the information asked for will be supplied to him within ten days. No information however has been supplied to him by the respondent till date.

4. Sh.
