## Complaint Case No. 804 of 2019

PRESENT: None for the Complainant

#### ORDER:

The complainant through RTI application dated 23.07.2019 has sought information regarding power connection No.AP-34/2755(7.1/2 BHP) Bhagwan Singh s/o Atma Singh of Zira and other information concerning the office of SDO PSPCL Zira. The complainant was not provided the information after which the complainant filed a complaint in the Commission on 04.09.2019.

The case was first heard on 06.01.2020. Both the parties were absent. The case was adjourned.

The case was again heard on **27.01.2020.** The counsel appeared on behalf of the complainant informed that the PIO has not provided the information. The respondent was absent on 2<sup>nd</sup> consecutive hearing. The Commission observed that the complainant has filed RTI application on 23.07.2019 but has not gone to the First Appellate Authority. The Commission remanded back the case to First Appellate Authority with the direction to hear the case and dispose of the appeal within 30 days.

The Commission further observes that there has been an enormous delay of six months in attending to the RTI application by the PIO. The PIO was issued a **show cause notice** under Section 20 of the RTI Act 2005 and directed to file a reply on an affidavit.

Sh.Santokh Singh, AE O/o PSPCL Zira appeared late and informed that the information has been sent to the complainant. He was informed that the case stands adjourned.

On the date of last hearing on **23.06.2020**, the respondent present pleaded that the information was sent to the complainant vide letter dated 09.09.2019 but the same was received back due to incomplete address. The appellant was absent. The appellant was directed to contact the PIO and provide the correct address as well as collect the information.

The PIO was absent nor had sent any reply to the show cause notice issued on 27.01.2020 for delay in attending to the RTI application. The PIO was given one last opportunity to appear personally on the next date of hearing and file a reply to the show cause notice on an affidavit otherwise the Commission will be constrained to take action against the PIO as per provision of RTI Act.

### Complaint Case No. 804 of 2019

### Hearing dated 09.12.2020:

The case has come up for hearing today through video conferencing at DAC Ferozepur. The respondent present pleaded that after the information sent earlier to the appellant was returned back by the postal department as undelivered they contacted the appellant on her mobile, and came to know that she was travelling abroad, after which the information was sent to the appellant via an email.

The appellant is absent. The Commission's notice served to the appellant (6.11.2020) for the hearing of today has also been returned back by the postal department with the remarks of postal authority "left India" thus corroborating the plea of the respondent.

The Commission has also received a reply to the show cause notice from the PIO on 20.08.2020 which has been taken on the file of the Commission.

Since the information stands provided via an email and the above circumstances clearly indicate that the delay caused was not because of any malafide intention on the part of the PIO, I accept the plea of the PIO and drop the show cause. And since the case was remanded back to the first appellate to hear it as per the RTI Act, but the information has already been provided, the first appellate is also directed to close the case.

No further course of action is required. The case is **disposed off and closed**.

Since the information has been provided, no further course of action is required. The case is **disposed off and closed**.



ORDER:

The appellant through RTI application dated 01.11.2019 has sought information regarding Grants received/utilized in the division from 01.10.2018 to 01.11.2019 in DeraBassi, Sub Division No.2, 10 & 11-SAS Nagar, - Work order book in all divisions — comparative statements of works and other information concerning the office of Xen, Water Supply & Sanitation Division No.3, SAS Nagar. The appellant was not satisfied with the reply of the PIO dated 27.11.2019 vide which the appellant was asked to deposit Rs.2640/- as requisite fee after which the appellant filed first appeal before the first appellate authority on 27.12.2019 which took no decision on the appeal.

ORDER:

The appellant through RTI application dated 27.01.2020 has sought information regarding copy of rules/instructions for issue of water bill and other information concerning the office of SDE Water Supply and Sanitation Division No.2, Mohai. The appellant was not provided the information after which the appellant filed first appeal before the first appellate authority on 04.03.2020 which took no decision on theappeal.

On the date of first hearing on 06.10.2020, the appellant claimed that the PIO has not provided the information.

The respondent present informed that as per practice, the water bill is issued bimonthly but there is no such rule. The PIO was directed to provide a copy of noting/order/instructions that may suggest a methodology to generate water bills.

Regarding the point that whether there exist any instructions regarding the procedure to be followed while dispatching water bills, The PIO was directed to provide a guideline if it exists. Rest of the information sought was vague and were random queries.

### Hearing dated 09.12.2020:

The case has come up for hearing today through video conferencing at DAC Mohali. The respondent present pleaded that the information has been supplied to the appellant vide letter dated 02.12.2020 with a copy to the Commission.

The appellant claims that the information has been supplied with a delay of more than ten months.

At the last hearing, it was observed that the information sought by the appellant was ambiguous and a lengthy discussion had followed. After the discussion, the crux of the RTI application was arrived at, after which the PIO was directed to provide all documents, subject to their availability, any instructions regarding the procedure to be followed while dispatching water bills. The information has been provided.

The case is **disposed off and closed.**
