1. 4. In today's hearing, appellant, Sh. Dilbag Chand is absent without any intimation to the Commission for today's hearing. A last opportunity was given to the appellant to represent this case today but he failed to do so.

1. Appellant, Sh. Ravinder Singh Gill brought into the notice of the Commission through letter dated 14.09.2020 (vide diary no. 12541 dated 22.09.2020) that respondent PIO had supplied him compensation cheque amounting Rs. 1,500/- from the account of Sh. 2. 4. In today's hearing, respondent, Sh. Bhupinder Singh apologies and states that due to shortage of time cheque was given from the individual's account. He mentioned that compliance of order of the Commission dated 23.06.2020 regarding compensation is in process and requested for an adjournment in this case. He also requested the appellant to return the earlier provided demand draft.
5. On this, appellant, Sh. Ravinder Singh Gill assures that he will return the previous demand draft to the respondent.
