Order:

1. This order may be read with the previous order dated 30.09.2021 vide which appellant pointed out the deficiency in the supplied information and he intimated the Commission that information in connection with point 1, 3 & 4 is still pending.
2. Respondents, Ms. Kulwinder Kaur and Sh. Gurbax Singh stated that the information in connection with the above said points 1, 3 and reply with regard to point no. 4 have already been supplied to the appellant yesterday via an email on his email address [lawofficeofhimanshuraj@gmail.com](mailto:lawofficeofhimanshuraj@gmail.com). She also presented a copy of the same before the Commission during the hearing.
3. Appellant, Sh. Himanshu Raj denied of receiving the same. Appellant also intimated the Bench that respondent PIO is not supplying information relating with RTI application (refer to the letter dated 09-02-2010).
4. Accordingly respondent PIO was directed to send the requisite information in connection with point no. 1, 3 and 4 by today on his email address i.e. [lawofficesofhimanshuraj@gmail.com](mailto:lawofficesofhimanshuraj@gmail.com) under intimation to the Commission.

Respondent PIO was also directed to send an affidavit in original to the appellant duly attested by the competent authority as per queries raised in RTI application within one week from today with a copy to the Commission.

Ms. Kulwinder Kaur assured that she would send information via an email by that day and she would also supply an affidavit as per the directions of the Commission. The case was adjourned for further hearing for 9.12.2021.

5. In today's hearing, both the parties are present and Ms. Sapna appearing on behalf of the appellant requests for an adjournment for 14.12.2021, which the court pleases to grant.
