Order:

1. This order may be read with the previous order dated 30.11.2021 vide which, respondent, Ms. Jasbinder Kaur stated that the matter was under process and the latest reply dated 29.11.2021 had already been sent to the appellant. She added that that information relates with other branches and they were only supposed to forward the RTI applications concerned and they might not force the departments to supply the information.

Representative of the appellant, Ms. Gurinder Kaur requested the Commission that suitable directions may be given to the respondent department to supply the information as per RTI application since sufficient time has gone in vain. She also stated that she was going to retire from the services of the department soon.

Respondent PIO was directed to send an affidavit in original to the appellant duly attested by the competent authority as per queries raised in RTI application within one week from that day with a copy to the Commission. Matter was adjourned for further hearing on 09.12.2021 i.e. today.

2. In today's hearing, respondent, Ms. Jasbinder Kaur states that they have sent an affidavit to the appellant today copy of the same has also been sent to the Commission via an email dated 09.12.2021, which is received by the undersigned Bench and placed on record.
