ORDER

This order may be read with reference to the previous order dated 26.8.2020 vide which the letter dated 1.6.2020 received from the respondent-Public Information Officer was sent to the appellant to file his submissions and due to administrative reasons the case was adjourned to 1.10.2020.

2. During the hearing today i.e. 1.10.2020 the representative of the respondents states that no submissions have been received from the appellant. He further states that the information pertaining to Point No. 4 and 5 of the RTI application has already been provided to the appellant. Regarding Point No. 3 of the RTI application, the representative of the respondents states that the appellant has been advised that the matter relates to the Punjab Public Service Commission and he may sought the information from that organisation with which the appellant shows his satisfaction. Regarding Point No. 1, 6 and 7 the representative of the respondents states that no specific information has been sought by the appellant and a letter was issued to him on 1.6.2020 even though nothing has been received from him. In addition he also states that the remaining information, which is not specific, relates to the 3rd party. Regarding Point No. 2 of the RTI application, the representative of the respondents states that the concerned file is around 16-17 years which is being traced and the same will be provided to the appellant as and when the file will be traced. However, the appellant states that the respondent-Public Information Officer may be directed to supply the remaining information pertaining to Point No. 1,2,6 and 7.

3. After hearing both the parties, the appellant is advised to file the rejoinder on the letter dated 1.6.2020 written by the respondent authority to the respondent-Public Information Officer with a copy to the Commission. A copy of the letter dated 1.6.2020 is sent with this order. Since, the appellant has sought the 3rd party information, before taking a final view on the matter, the appellant is also advised to establish the public interest in seeking the 3rd party information. Also the respondent-Public Information Officer is directed to file his reply/response, in case any rejoinder is filed by the appellant before the next date of hearing to take the matter to its logical end.
