- 3. However, the representative of the respondents Sh. Sanjeev Garg, Deputy Director Rural was present during the last hearing on behalf of the Sh. M.S. Chhatwal, IAS, Director, Rural Development & Panchayat, Pb. and assured that the complete information will be supplied to the complainant before the next date of hearing and according to his request the case was adjourned. But today i.e. 4.10.2021 he is absent without intimation and also incomplete information has been supplied to the complainant so far.
- 4. It is a fact on record that the copies of orders of the Commission are being sent to the Public Information Officer o/o Director, Rural Development & Panchayat Deptt.,Pb. Director, Rural Development & Panchayat Deptt.,Pb. as well as to the Block Development and Panchayats Officer, Mamdot through registered post but the order of the Commission are not being complied with.
- 5. The perusal of the file shows that in this case, application for information was filed on 15.06.2020 but after lapse of more than one year, incomplete information has been given to the complainant so far. It is, thus apparent from the response of the respondents that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act. 5. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 10,000/- (Rupees Ten Thousand only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer by the office of the Director, Rural Development and Panchayats, Punjab before the next date of hearing as the case was adjourned on 6.9.2021 on the assurance given by Sh. Sanjeev Garg, Deputy Director, Rural, and he is absent without intimation, and the incomplete information has been supplied to the complainant. In addition, he is also directed to ensure that the complete information be supplied to the complainant before the next date of hearing.
- 6. Also a reply regarding show cause notice issued to Sh. Ruldu Singh, Panchayat Secretary has been received and the decision on the same will be taken on the next date of hearing.
