The respondent PIO, represented by Gurpreet Kaur, Building Inspector, stated that the information was sent to the appellant on 4.9.2020 and he was also invited to the Municipal Corporation for inspection as requested in his RTI application. However, he has still not gone to the office for said inspection.

3. The respondent PIO is directed to arrange for an inspection of a record cited in this RTI application on Friday 9.7.2021.
