1. “Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub Section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or

destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of 250/- Rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed Twenty Five Thousand Rupees;

Provided that the Central Public Officer or the State Public Information Officer, as the case may be, shall be given a reasonable opportunity of being heard before any penalty is imposed on him;

Provided further that the burden of proving that he acted reasonably and diligently shall be on the Central Information Officer, as the case may be."

The onus and responsibility lie on the PIO to ensure the transmission of the complete information to the appellant. The **concerned PIO**, is hereby held guilty for not providing the information on time as prescribed under Section 7, which is within 30 days of the receipt of the request and for repeated and willful defiance of the Punjab State Information Commission's orders.

A penalty of Rupees Five Thousand (Rs. 5000.000) is hereby imposed upon the **concerned PIO**, which be deducted from his salary and deposited in the Punjab Government Treasury under head "**0070-Other Administrative Services-60-other Services-800-Other Receipts-86-Fees Under the Right to Information Act.**" The **concerned PIO** is directed to duly inform the Commission of the compliance of the orders by producing a copy of the challan. Copies of this order be sent to the parties through registered post.

4. The respondent PIO is further directed to supply duly attested copies of the information requested in this RTI application to the appellant with a copy to this Commission within 15 days of receipt of this Order. This Appeal Case is hereby **Disposed of**. A copy of this Order be sent to the Registry Branch for follow-up of compliance.
