The RTI application is dated 15.06.2018 whereby the information-seeker has sought information as mentioned in his RTI application. He filed complaint in the Commission on 1211.2018 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).

- 2. Notice was issued to the parties for hearing for 10.01.2019 in the Commission
- 3. The complainant states that no information has been given to him so far.
- 4. Respondent states that the information demanded by the complainant is third party information.
- 5. After hearing both the parties and gone through the case file, it is observed that the information demanded by the complainant is third party information, which cannot be given to the complainant. Regarding point no 2, respondent is directed to provide first page of ACR to the complainant. The complainant expressed his satisfaction over the same
- 6. In view of the foregoing, no cause of action is left, the complaint filed by the Complainant is therefore **disposed of and closed**. Copy of the order be sent to the parties.
