ORDER:

This order may be read with reference to the previous order dated 28.09.2021.

- 2. The appellant states that information of point No. 1 & 3 has been received but information of point No.2 has not been supplied by the respondents.
- 3. Sh. Subhash Aggarwal, RTI Consultant, attending the hearing for the respondent-PIO states that as far as supply of remaining information is concerned, it is stated that records prior to 2012-13 onwards were digitalized and records prior to this period have been dumped being too old and searching such old records will be voluminous task and disproportionately diversify their resources and as such could not be provided in view of para 37 of Supreme Court verdict dated 09.08.2021 in the matter "Central Board of Secondary Education Vs. Aditya Banopadhyaya and others" (Civil Appeal No.6454 of 2011).
- 4. Examination of case file reveals that Email No.LC/RTI/523-524, dated 10.11.2021 received in the Commission from the Respondents is taken on record. It has further been noted that copy of this email has also been sent to the appellant by the respondents. The extracts of verdict of Supreme Court of India in the Civil Appeal No.6454 of 2011, given in the matter "Central Board of Secondary Education Vs. Aditya Banopadhyaya and others" at para 37 reproduced as under:-

public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted in a tool of oppression or intimidation of honest officials striving to do their duty. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of public authorities prioritizing 'information furnishing', at the cost of their normal and regular duties."

4. In view of the above, sufficient information has been provided to the appellant by the respondents and hence, **the case is ordered to be disposed of and closed**. Copies of the order be sent to the parties.
