- 2. Shri Harjeet Singh, appellant comes present through CISCO Webex to attend the hearing and states that he has received the information sent by the PIO, but it is not sent within the stipulated period. He further states that vide his e-mail dated 23.11.2021 he has brought this fact to the notice of the Commission that the PIO has made false claim that he has sent letter to me regarding the deposit of requisite fee, however in actual he has not sent the claimed letter. He further requests to initiate legal action against the PIO.

3. Shri Sukhwinder Singh, Sr. Asstt. comes present through CISCO Webex and

states that the sought for information was twice sent to the appellant through registered post,

firstly on 09.12.2021 and secondly on 04.01.2022.

4. After the perusal of the case file, it is found that during the course of hearing on

01.11.2021, the PIO vide his e-mail claimed that letter no.1249 dated 15.04.2021 was written to

the appellant regarding the deposit of requisite fee of Rs.170/-. But the appellant denied receipt

of any such letter sent by the PIO. The Ld. State Information Commissioner, Shri Avtar Singh

Kaler had, thus, directed the PIO to provide the attested copies of sought for information to the

appellant free of cost.

5. The PIO has sent the requisite information twice to the appellant free of cost.

Thus, the matter needs no further intervention of the Bench.

6. In view of the above, **the case is disposed off and closed**. Copy of the order

- 2. Shri Vinod Gupta, appellant comes present through CISCO Webex to attend the hearing and states that the sought for information has not been provided to him by the PIO till date.
- 3. Shri Sanjeev Kumar, DDPO, Ludhiana and Shri Gurpartap Singh Gill, BDPO, Ludhiana-2 come present to the attend the hearing through CISCO Webex. Shri Sanjeev Kumar, DDPO, Ludhiana states that the information sought by the appellant relates with the office of the BDPO, Ludhiana-2.

4. Shri Gurpartap Singh Gill, BDPO, Ludhiana-2 states that the information has

already been sent to the appellant on 09.07.2021 and now the amount of compensation of

Rs.5,000/-, which was awarded in favour of the appellant has also been paid to the appellant

vide Demand Draft No.010013 dated 04.01.2022.

5. The appellant states that he is not satisfied with the information sent by the PIO

as he sought information regarding the usage of grant of Rs.12.57 Lakhs for the construction of

streets and sewerage in Mohalla Ram Nagar, but the PIO is providing information regarding

Gram Panchayat, Guru Nanak Nagar.

6. The respondents states that the grant of Rs.12.57 Lakhs was sanctioned for the

work in Gram Panchayat, Ram Nagar, not for Mohalla Ram Nagar.

7. Under these circumstances, Shri Sanjeev Kumar, DDPO, Ludhiana and Shri

Gurpartap Singh Gill, BDPO, Ludhiana-2 both are directed to file affidavits on non judicial stamp

paper duly signed by them and attested by the Notary Public to the effect that the grant of

Rs.12.57 Lakhs was sanctioned for the work in Gram Panchayat, Ram Nagar, not for Mohalla

Ram Nagar and thus, has been used for works in Guru Nanak Nagar which falls in the

jurisdiction of Gram Panchayat, Ram Nagar. It be further stated that nothing has been

concealed therein and the statement made is true and correct. The original affidavit be sent to

the appellant and photocopy of the same be sent to the Commission for record within 3 weeks.

8. With the aforesaid directions, the present appeal case is disposed of and

closed. Copies of the Order be sent to the concerned parties.
