Final opportunity was given to the respondent-PIO concerned either to supply the remaining required samples of the material regarding point no. 03 of the RTI request positively to the appellant after inspection or file a reply, in writing, to the particular query no. 03 of the RTI request, to the appellant with a copy to the Commission. Another opportunity was given to the appellant to confirm whether he has received the information/reply, or not.

The appellant, Sh. Ramandeep Singh Ahluwalia, who appeared in today's hearing, orally states that the concerned official was not be available on 24.12.2020 on the related site to provide required samples of the material regarding point no. 03 of the RTI request .

Sh. In view of the above, <u>a show cause notice under Section 20 (2) of the RTI Act is issued to</u> <u>Public Information Officer concerned of office of Executive Officer</u>, <u>Municipal Council</u>, <u>Khanna</u>, <u>as to why</u> <u>disciplinary action be not recommended against him for willful delay in supplying the</u> <u>information to the RTI applicant</u>, <u>under the provisions of the RTI Act</u>, <u>2005</u>.

He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed <u>through facility of</u> <u>Software/application 'CISCO Webex Meetings'</u>, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. <u>A copy of this</u> <u>order be sent to him through registered post</u>.
