This order may be read with reference to the previous order dated 18.1.2021.

2. The appellant has sought the following information:-

3. The representative of the respondents states that the complete information has already been supplied. He has also sent the receipt of 567 pages of information related to Point No. 1,3,4,5 and 6 of the RTI application vide No. spl 1 dated 19.1.2021 and also receipt related to Point No. 2 of the RTI application vide No. spl 1 dated 9.2.2021 given by the appellant. Also the appellant states that he is satisfied with the information so supplied by the respondents. He further states that he has no objection if the case is closed.

4. According to the submissions made by the appellant, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
