**ORDER:**

The complainant through RTI application dated 04.03.2020 has sought information regarding Mandir Shri Ram Chander Ji(Regn. No.222) Bathinda – immoveable property - Bank balance/FDS – shops given on rent - Members of the trust - Bank balance of Lala Moti Ram Memorial Vridh Ashram – shops on rent – members of the trust and other information as enumerated in the RTI application concerning the office of DV Bathinda. The complainant was not provided the information after the appellant filed a complaint in the Commission on 29.07.2020.

The case has come up for hearing today through video conferencing at DAC Bathinda. The appellant claims that the PIO has not provided the information.

The respondent is absent. The Commission has received a copy of letter from APIO-DC Bathinda on 04.01.2021 vide which the PIO has transferred the RTI application to the Manager, Lala Moti Ram Memorial Vridh Ashram Bathinda asking them to provide information.

The Commission has also received a letter from Trust Shri Ram Chander Ji stating that there is no senior citizen home in the name of Lala Moti Ram Memorial Bridh Ashram, Bathinda, however, the society Trust Shri Ram Mander Ji is running a Senior Citizen Home on Amrik Singh Road, Bathinda.

In the reply, the respondent society has further pleaded that it is not a public authority within the ambit of section 2(4) of the RTI Act. It claims that it has not been established under the Constitution of India, Central/State Laws and is a private charitable institution owned and managed by Trust Mandir Ram Chander Ji, which is a religious institution. According to its letter, it is neither funded by the central or state Government, nor obtains any grant in aid from the State Govt.

The above plea of the Trust is accepted. The case is **disposed off and closed**.
