- 5) ਉਪਰੋਕਤ ਸ਼ਿਕਾਇਤ ਤੇ ਰਿਪੋਰਟ ਮਿਲਣ ਉਪਰੰਤ ਮਾਨਯੋਗ ਕਮਿਸ਼ਨਰ ਜੀ ਵੱਲੋਂ ਕੀਤੇ ਹੁਕਮ/ਟਿੱਪਣੀ ਦੀ ਤਸਦੀਕ ਕੀਤੀ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।
