**ORDER**

1. The appellant filed second appeal was in the Commission on 06.01.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing on 10.03.2021 through CISCO WEBEX. It is observed that following dates which were mentioned in the hearing notice in English format are correct instead of Punjabi format, which may be read as below:

2. In today's hearing, appellant, Sh. Shishu Paul Verma appearing in the Commission and states that RTI application was filed on 21.10.2020 but till date requisite information is not supplied by the respondent PIO. He shows his dissatisfaction with the supplied reply, as that is not certified by the concerned respondent PIO.

He requested the Commission to direct the respondent PIO to supply the requisite information along with permission for Videography. He added that in Appeal No. CIC/WB/A/2006/00144 dated 20.03.2006 and CIC/AD/A/09/00215 dated 23.02.2009 approval is given for Videography by the Central Information Commission. He submits copy of both the orders passed in Appeal No. CIC/WB/A/2006/00144 dated 20.03.2006 and CIC/AD/A/09/00215 dated 23.02.2009, which are taken on record. He also submitted his written submission dated 10.03.2021, which is also taken on record.

3. Respondent PIO is not present for today's hearing but an email dated 10.03.2021 is received from the respondent, Advocate, Surajpreet Singh Kang from email ID [surajpreetadv@gmail.com](mailto:surajpreetadv@gmail.com) requesting therein for an adjournment in this case. This email is taken on record.
4. After hearing the appellant and examining the case file, it is observed that:
- A reply from respondent PIO vide letter no. 1275 dated 05.03.2021 has been received in the Commission vide diary no. 5392 dated 08.03.2021 stating that through a letter dated 11.11.2020, appellant was called for inspection of record on 20.11.2020 (as per reply of the respondent dated 11.11.2020 at 12:00 Noon and after 04:00 PM to inspect record as per Section 2(j) of the RTI Act) but appellant intimated the respondent PIO on 17.11.2020 to supply the requisite information first and he filed First Appeal on 20.11.2020.
  - In that reply respondent PIO also mentioned that requisite information has been sent through registered post to the appellant dated 05.03.2021 comprising 62 pages (in connection with point no. 1 to 5 as per RTI application) and in connection with point no. 6 respondent PIO mentioned as follows:
