3. The respondent requests that appellant may again be advised for an inspection in the present and ensures that after inspection the entire information shall be provided to the appellant.
4. In view of the above, the appellant is advised to visit office of EO, Improvement Trust, Bathinda tomorrow i.e. 11.05.2022 during office hours and get the record inspected as per his RTI application. The respondent is also directed to supply the pointed out information without fail, under intimation to the Commission.
