3. The perusal of the file shows that the information sought by the Complainant is third-party information. Moreover, the so-called third party has also given his consent not to provide his personal information. In view of the same, no further cause of action. Therefore, the Complaint case filed by the Complainant is **disposed off and closed**. Copy of the orders be sent to the parties.
