5. It is appropriate to mention that the "Information" means as per the provisions of the RTI Act, 2005, any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, report, papers, samples, models data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

6. Furthermore, it is relevant to mention Section 2 (*j*) of the RTI Act, 2005 which is as follows:-

"right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to-

(i) inspection of work, documents, records;

(ii) taking notes, extracts or certified copies of documents or records;

(iii) taking certified samples of material;

(iv) obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.

7. In accordance with the submissions made by the respondent-Public Information Officer-cum-Tehsildar Sh. Lakshey Kumar, his request is accepted as the information as available in the office has already been supplied by the respondent-Public Information Officer. Therefore, the show cause notice issued to him in this case is hereby withdrawn.
